IF THIS HAPPENS	DO THIS
Tanker/Vehicle Accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks.  Call the emergency services: Dial 111
Spill or leak	Do NOT touch or walk through spilled material. Wear PVC overalls, chemical resistant gloves, facemask or goggles. Stop leak when safe to do so. Prevent entry into waterways, drains, or confined areas. Adsorb spilled product and place in sealable container for disposal. Wash down affected area with water plus detergent. Absorb and collect washings and place in the same sealable container for disposal. Seek advice from the local authority regarding disposal.
Fire	Call the Fire Service: Dial 111. This product is combustible. Decomposition products in a fire are toxic and or irritant. When fighting a major fire wear an air-supplied respirator. Wear protective equipment. Extinguish warehouse and factory fires using dry chemical extinguisher, foam, carbon dioxide or fine-water spray. DO NOT use direct jet of water. Cool sealed drums with water to prevent rupture due to thermal expansion. Contain run-off. Keep non-involved persons away.
